## TOWN OF CAREFREE, ARIZONA ORDINANCE NO. 2003-13

AN ORDINANCE OF THE TOWN OF CAREFREE, MARICOPA COUNTY, ARIZONA, GRANTING A SPECIAL USE PERMIT TO THE CAREFREE WATER COMPANY TO USE CERTAIN REAL PROPERTY TO CONSTRUCT AND OPERATE A ONE MILLION GALLON WATER RESERVOIR AND A VERTICAL TURBINE PUMP STATION ON LOT 7 AND TRACT 'A' OF THE CAREFREE VELVET SHADOWS SUBDIVISION; AND IMPOSING CERTAIN CONDITIONS ON SUCH USE.

## BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAREFREE, MARICOPA COUNTY, ARIZONA AS FOLLOWS:

<u>Section 1.</u> Pursuant to Section 1601 of the 1996 Town of Carefree Zoning Ordinance, a special use permit shall be and hereby is granted to the Carefree Water Company to use the real property, shown as Parcel 016 & 058 in the Maricopa County Assessor's Book No. 219 Map 11, for the construction of a one million gallon water reservoir and a vertical turbine pump station, as disclosed in Application No. Z03-02 and the accompanying site plan.

## <u>Section 2.</u> The special use permit shall be and is subject to the following conditions:

- 1. No development, construction traffic or debris shall encroach within the drainage easement shown on the subdivision plat.
- 2. No lights shall be placed above the eight (8) foot tall security fencing surrounding the pump station.
- 3. Mature twenty-four inch (24") box trees shall be placed around the east, west and north perimeter of the water reservoir and west side of the enclosed pump station at a distance of twenty-five (25) feet on center. All trees shall be placed on an irrigation system. Irrigation plans and landscape plans shall be provided at time of building permit application.
- 4. Prior to issuance of building permits, a dust control permit shall be obtained from the Maricopa County Environmental Service Department and storm water runoff permit, if required, from the Arizona Department of Environmental Quality.
- 5. A temporary chain link fence shall be installed around the construction site prior to any site disturbance. The fence shall remain in place until construction of all site improvements is completed.

<u>Section 3.</u> The Town of Carefree Zoning Map is hereby amended to reflect the issuance of the special use permit granted hereunder.
