## TOWN OF CAREFREE, ARIZONA ORDINANCE NO. 2008-02

AN ORDINANCE OF THE TOWN OF CAREFREE, MARICOPA COUNTY, ARIZONA, ADOPTING AMENDMENTS TO CHAPTER 6, TO PROVIDE FOR A NEW ARTICLE 6-6, OF THE TOWN OF CAREFREE CODE AMENDED THROUGH JANUARY 8, 2008; PROVIDING FOR REPEAL OF CERTAIN PROVISIONS OF THE TOWN CODE; PROVIDING FOR SEPARABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAREFREE, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

<u>Section 1.</u> The Mayor and Common Council deem it necessary, in order to conserve, promote, and protect the public health, safety and welfare, to amend that certain document known as the Code of the Town of Carefree, Arizona.

<u>Section 2.</u> The amended Code of the Town of Carefree, Arizona shall be known as the "Code of the Town of Carefree, Arizona, amended through February 5, 2008," and is hereby declared to be a public record. Three (3) copies of said amended Code are hereby placed and ordered to remain on file in the office of the Town Clerk.

<u>Section 3.</u> All ordinances or portions of ordinances in conflict with the provisions of this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

<u>Section 4.</u> The amendments are made to Chapter 6, Article 6-6 of The Town of Carefree Code Amended Through January 8, 2008, as follows (added language is shown in **bold**, deleted language is shown <del>crossed out</del>):

Chapter 6 OFFENSES

Article 6-6 Landscaping Debris

Section 6-6-1 Offenses

No person shall blow any landscaping debris into public roadways at any time.

Section 6-6-2 Violations and Penalties

Any person who violates, disobeys or refuses to comply with, or who resists the enforcement of any provision of this Article shall upon admission or judicial determination thereof be responsible for a civil offense and shall be subject to imposition of a civil sanction of up to \$750.00.

<u>Section 5.</u> This Ordinance and stated amendments shall become effective and in full force and effect thirty (30) days from and after the date of its adoption.

<u>Section 6.</u> The Town Clerk of the Town of Carefree shall incorporate the Amendment set forth herein into the Town Code of the Town of Carefree, Arizona.
